#### 20/114 Apologies - none

## 20/115 Interests

- a. There were no declarations of interest from councillors on items on the agenda.
- b. No written requests for dispensations for declarable interests had been received.

#### 20/116 Minutes

#### 20/117 Public Issues

### a. Road signs on Hempstead Lane

The speed limit and give way signs at the junction of Pouchen End Lane and Hempstead Lane had been missing for some time. The issue had been raised with Hertfordshire Highways who had advised that it was low priority.

**Agreed** that as both signs were technically outside the parish and division, Cllr Douris would raise the matter with the appropriate county councillor.

#### b. Remembrance Day Service

There was no representative from the Parish Council at the annual Remembrance Service but the council had understood that the service had been cancelled.

#### b. Village noticeboard

The noticeboard in the grounds of the shop used for public notices was in need of repair.

**Agreed** that the sign was necessary and that the clerk would investigate options to repair it.

c. Noted that the incidence rate of Covid-19 in Dacorum in the last seven days was 125.1 cases per 100,000, up 10.3% since the previous week, compared to 169.54 cases in Hertfordshire and a national average of 257.3. Numbers in Dacorum were varying quite significantly week to week.

The bird boxes in the Old Green had been cleared, about half were being used, a fallen branch had been removed from the footpath and the vegetation on the bank had been cleared. The Tommy silhouette had been removed from The Green. In general litter was light. The new wheelbarrow was *in situ* at the burial ground.
