23/017 Public Issues

- **a.** An update was requested on the status of discussions with the cricket club about their tenure on the sports field. The clerk advised that agreement had almost been reached. Concern was expressed that the existing netting needed to be repaired before the start of the season. The clerk was asked to write to the club accordingly.
- **b.** A number of residents expressed concern about proposals to remove trees covered by a TPO from Browns Spring Wood (23/023.c 23/00314/TPO).

23/018 General matters outstanding

- **a. Old Green bridle path sign** agreement had been reached with Dacorum for the installation of a new sign.
- b. National Trust Estate Committee Geoff Brown had agreed to be the parish representative.

23/019 Correspondence received

- **a. Police** in the past month there had been one report of a theft from a motor vehicle and one report of damage to a motor vehicle. The Parish PCSO had patrolled Vicarage Road specifically about cars parking on kerbs. (See 23/021.c).
