	The Chairman advised the meeting that councillors, staff and contractors had a right to go about the council's business without harassment, alarm or distress.
23/099	Apologies for absence were received and accepted from Cllrs Berry and Westenholz-Smith.
23/100	Declaration of interests - none
23/101	Minutes

Resolved that the minutes of the extraordinary meeting of the Council at 7.30pm on the 6th September 2023 as circulated to members be signed as a correct record. Agreed unanimously

23/102 Public Issues

- a. The council was asked to respond to an email expressing concern at cricket balls being outside the sports field.
- b. Concern was expressed that Highways were being too slow in addressing the flooding at 76 Hempstead Lane (see 23/106.c). Noted that the residents of No 76 hadn't been contacted with advice by Highways Officers as reported and the clerk agreed to clarify.
- c. Concern was expressed that the proposed use of The Green by Martins Pond PH for bikers meets (see 23/107.b) would be too noisy and unsafe. That the plans for marshalling were inadequate/ That the use of The Green for commercial events was inappropriate, and that it would set an unwelcome precedent. It was noted separately that the police and licensing officer had no concerns with the proposals.
- d. Concern was expressed at the publishing of drone footage showing back gardens in the village.
- e. Concern was expressed that the 30mph signs on Vicarage Rd started a little distance away from the junction with Nettleden Rd and it was asked whether they could be moved?

23/103 Correspondence received

- a. Concern had been expressed at speeding along Frithsden Lane and Hempstead Lane.
- **b.** Concern had been express about the encroachment of hedges by the school and 17 Hempstead Lane. The school's hedges had been cut back but 17 Hempstead Lane was still a problem. Agreed that the Warden would cut the hedges back.

- **c.** Noted that Dacorum was undertaking a review of polling places.
- **d.** Noted that a complaint had been received about a bonfire on the allotments which had been lit outside the November to February period agreed last December (22/149.a). The allotment holders had been reminded of the agreement.
- **e.** Noted that tree roots from a tree on Spencer Holland had intruded on The Anchorage, Vicarage Rd and need to be cut back. Advice was being sought on whether that might affect the stability of the tree.

23/104 General matters outstanding.

a. Noted that the new noticeboard had been installed.

23/105 Parish Warden – general litter picking and grass cutting had been undertaken.

Undergrowth and low hanging trees along the boundary of the football pitch had been cut back. Low hanging trees on the footpath to the Old Green had been cut back. The playground had been inspected. The noticeboard had been installed.

 - Cllr Douris reported that Nettleden Rd had been upgraded to a primary gritting route from 2023.
 - ii. Cllr Nelson reported that during a recent DriveSafe exercise on Water End Rd, 59 or 20% of 274 cars had exceeded 35mph which triggered a letter from the police.
